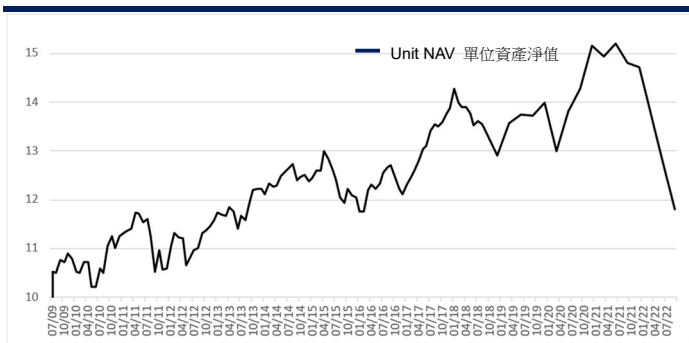

Important Information 重要資料

Fund Commentary 基金評論

It was a tough month for global equities as all regions end September lower. A challenging macroeconomic environment continues to play out, shifting investor sentiment to a widespread risk-off tone. In a reversal of fortunes from recent months, emerging markets underperformed developed markets, with Asia lagging most. US equities continued to decline over the month. European shares ended lower in September as inflation continued to hit fresh highs. Offshore Chinese equities delivered a negative return. Bond markets continue to suffer in another challenging month, especially in the UK with the arrival of a new government with new policy. Global central banks continued to tighten the monetary policies as US Federal Reserve delivered a third straight 75bps rate hike and projected another 100-125bps of rate hikes at the final two meetings for the year in the "dot plot".

全球股市在9月份舉步維艱，因為所有地區的股市9月份都低收。宏觀經濟環境荆棘滿途，投資者情緒普遍轉向避險為基調。新興市場的表現落後於發達市場，扭轉最近幾個月的形勢，其中亞洲最為落後。美國股市在月內持續下跌。由於通脹續創新高，歐洲股市9月份低收。中國離岸股市則錄得負回報。債券市場面臨又一個艱難的月份，步履蹣跚。英國新政府上任後推出新政策引起波動，其債市備受打擊。全球央行持續收緊貨幣政策，聯儲局連續第三次加息75點子，並在「點陣圖」中預測今年最後兩次會議將再加息100-125點子。

Remarks 備註

Risk Class 風險級別

每個成分基金均須根據該成分基金的最新風險指標為基礎，劃分為七個風險級別的其中一個風險級別。風險級別由強制性公積金計劃管理局（「積金局」）根據強積金投資基金披露守則制定，而該風險級別並未經香港證券及期貨事務監察委員會（「證監會」）審核或認可。

Risk class is assigned to each constituent fund according to the seven-point risk classification based on the latest risk indicator of the constituent fund. The risk class is prescribed by the Mandatory Provident Fund Schemes Authority ("MPFA") according to the Code on Disclosure for MPF Investment Funds and the risk class has not been reviewed or endorsed by the Securities and Futures Commission ("SFC").
